\* Campaign material or a disclaimer stating that no campaign materials have been produced must be submitted with Post Election reports. Electronic filers must send this by mail.

\*\* During this time period any contribution or loan which exceeds \$1,000 must be reported within 24 hours of receipt. This same contribution or loan must also be reported in the Post Election report. These may be faxed or filed via the Board's website.

**Note:**

- ▶ **If the filing date falls on a Saturday, Sunday or a Legal Holiday, the report is due the next business day.**
- ▶ **For electronic filers - filing year is the year in which the report is due to be filed.**
- ▶ **The periodic reports are required to be filed until the candidate or committee files a termination report. In order to terminate, you must have an ending cash balance of zero and all loans and liabilities have been repaid or forgiven.**
- ▶ **Election reports are required from all filers unless a Notice of Inactive Status (CF-20) is filed. This can now be filed under On-line Electronic Filing Options at the Board's website [www.elections.state.ny.us](http://www.elections.state.ny.us) link to Campaign Finance. However, periodic filings are required even from committees filing a Notice of Inactive Status.**
- ▶ **State filers should check the Board's website at [www.elections.state.ny.us](http://www.elections.state.ny.us) to confirm receipt of the report filed as well as accuracy of report content.**
